

## **Boatswain c.d.**

Superior: Officers

Deputy: Deck Repairman c.d.

### **Job description:**

Acting as a foreman of the deck crew.

### **Main tasks:**

- Tasks related to watches at sea and in port
- Organisation of tasks and detailed implementation
- Supervising the safe and diligent performance of tasks
- Providing induction training for new employees
- General tidiness and order on board the ship, in work areas and store rooms
- Helicopter operations
- Practical implementation of towing operations
- User of deck cranes and all other deck machinery
- Ship's mooring, unmooring and anchoring tasks
- Tasks in accordance with the muster list
- Repair and maintenance of the ship's structures
- Reception of water, provisions and supplies for the ship
- C.d. tasks on the engine side when necessary
- Other tasks assigned by the superior

### **Minimum qualifications:**

- Experience and knowledge on an icebreaker in Baltic Sea icebreaking. Minimum one year experience as a Deck repairman or Able Seaman.
- Requirements for personal qualities include good human skills for working as a foreman and a member of the crew in co-operation with others with minimal conflicts between other people on board.
- Ability to work at sea tolerating isolation, working well with other members of the crew, and tolerating vessel movements without getting seasick easily.
- Before assigning a steady position the details and qualities of a person need to be assessed with the superiors and the office for approval.

### **Minimum Requirements of Certificates and Training:**

The following competence and certification requirements are based on the Finnish law and regulations which apply to Finnish vessels sailing under the Finnish flag and the crews and owners of such vessels.

- Certificate of Competency - Boatswain II/5, III/4
- Combined Certificate of Proficiency - VI/1, VI/2.1, VI/2.2, VI/6.4
- Personal Survival Training, A-VI/1-1
- Fire Prevention and Fire Fighting, A-VI/1-2
- Elementary First Aid, A-VI/1-3
- Personal Safety and Social Responsibility, A-VI/1-4
- Survival Craft and Rescue Boat, A-VI 2-1
- Fast Rescue Boat, A-VI/2-2
- Security Training for seafarers with designated security duties, A-VI/6-2
- HLO Basic Training\*\*\*\*\*, Norwegian standard

\*\*\*\*\*The requirement is temporary suspended until the vessel participates in actual offshore operations but 11 named persons have completed the HLO Basic Training to secure possible Helideck Operations during the Project in Baffinland
