JOB SUMMARY:

The role of the Crane Operator is to operate the Vessel cranes safely and efficiently.

PRE-REQUISITES/QUALIFICATIONS:

- High School Diploma or Equivalent
- Canadian Able Seafarer Rating or STCW II/5 Equivalent
- Must be able to obtain Stage 3 Crane Certificate or Equivalent
- 1 Year Offshore Experience
- Previous Gangway Experience
- Previous Helicopter Landing Officer (HLO) Experience
- Good verbal and written communication skills in English
- Must pass Physical, Drug Screen and Background/Pre-Employment Screening Checks

DUTIES AND RESPONSIBILITIES:

- The Crane Operator is to ascertain that the cranes are operated safely and within Floatel International's and the Client's guidelines and the designed loads (SWL) by the de-rating tables applicable to existing weather and sea state condition
- Maintain the cranes on a daily basis. Weekly and monthly inspect the cranes by the manufacturer's recommendation and the maintenance schedule in Star. Ensure that repairs and preventive maintenance are properly carried out and that the cranes are at all times maintained to the highest standard.
- They are responsible for carrying out routine crane and deck machinery maintenance and any other such related duties commensurate with their abilities and as directed by the Chief Officer or their nominee.
- The Crane Operator is to ensure that a valid Work Permit is in force for work on the crane or other deck machinery requiring such a permit.

- They are responsible for reporting any malfunctions of the cranes or of any other equipment they know of, to the Deck and Engineer Officer on watch, and also when required to the Electrical Engineer and Electrical Technical Officer.
- They are also responsible for writing a thorough Handover which shall be completed and handed over to the Chief Officer and Chief Engineer before signing off as per 1000-218-03 Handover – Reporting Procedure.
- The Crane Operator shall act as HLO during the night shift
- The night Crane Operator reports to the CHO and BSN upon completion of the shift. The reporting should include, not limited to status of shift work assignments.
- By the ISPS and ISM rules, the responsibilities also include reporting as required by FIMS
- To be a part of the category management program if required
- They are to follow the ISPS tasks given by the SSO
- Other Duties as Assigned
