- Responsible for the implementations of FIMS on board, including Policies. They shall, without
  delay, report to the onshore organization possible modifications that they consider necessary to
  ensure safety and environmental protection. They are also responsible for regularly reviewing the
  system to identify and recommend improvements. A Record of 1000-210-06F1 Master's Review
  Form shall be maintained on board and is part of the Company Management Review.
- Evaluate all situations, whether normal or of an emergency nature, and take proper actions to
  avoid or minimize potential damages or losses, with special regards to life. All decisions and
  actions should be based on the safety of personnel and equipment and to further the interests of
  the Company and the Client.
- Has the overall responsibility for the safety and integrity of the vessel and the safety and discipline
  of the persons on board.
- Responsible for all reporting to appropriate authorities as required by International, flag State and local Rules and Regulations as well as FI Policies and Procedures.
- Ensure full understanding of the Safety Observation and STOP system and full participation in this system.
- Shall assist FI Management in the following activities:
  - o Review Gangway landing areas and DP Operation restrictions for new fields
  - Establish Local Specific DP Guidelines with Clients Representative
  - Review proposed anchor plans and (un-)mooring procedures;
  - Liaise with the CHO to ensure that all the necessary mooring equipment is on board:
  - Complete necessary paperwork on completion of a move:
  - Review "as laid" mooring plans & data.
- During anchor handling, the Offshore Installation Manager is in sole charge of the anchor handling operations, in conjunction with Client's Marine Representative and Masters of the AHTS'. They shall ensure that:
  - Before any operation, a meeting has been held so that all parties concerned are aware, fully briefed and acknowledge their responsibilities;
  - Master of the AHV's are aware of their tasks;
  - The survey Package (if required) and vessel's radars are fully operational;
  - o Before an anchor is set, that all parties are in agreement on its position;
  - Guide an AHV at any time of the operation as they see fit;
  - They do not alter the proposed laid positions without first advising the office.
- The Offshore Installation Manager is in sole charge of any emergency response on the Floatel Vessel. Within 500m safety zone, the responsibility between the Master/OIM on the Floatel Vessel and the OIM on the Client's Installation is laid down in the project-specific Bridging Document.
